INTENT

1. This addendum is issued to provide for modifications to the above referenced RFP to clarify that the “irrigation/sprinkler specialist” (alternately described as the “qualified sprinkler specialist”) required under the RFP is intended, based on nature of the services required, to be a person classified under the Landscape Maintenance Laborer prevailing wage category set forth by the Department of Industrial Relations. Acknowledgment of this addendum shall be made in the Proposal Letter (see Appendix ‘E’) required as a part of each proposer’s submittal.
2. The Commission does hereby modify RFP Statement of Work – Work Force – Article III paragraph (C), page 15, to replace this paragraph in its entirety with the following:

Paragraph C:

The Contractor shall identify an individual who will be available at all times required herein, and who is qualified to complete complex landscape maintenance work, including servicing of irrigation and sprinkler systems, and repairing of equipment used in such landscape maintenance (referred to herein as the “irrigation/sprinkler specialist” or the “qualified sprinkler specialist”).

3. The Commission does hereby modify RFP Appendix J – Prevailing Wage Determinations as follows:

Dear Public Official:

The current prevailing wage determination for Landscape Maintenance Laborer in your county will be in effect until superseded by the Director. A description of the landscape work covered is provided below for your immediate reference. Please retain this letter in your records until further notice:

ROUTINE - mowing, watering, pruning, trimming, weeding, spraying, occasional planting and replacement of plants and janitorial work incidental to such landscape maintenance.

COMPLEX - servicing of irrigation and sprinkler systems, repairing of equipment used in such landscape maintenance.

Note: This determination does not apply to work of a landscape laborer employed on landscape construction (work incidental to construction or post-construction maintenance during the plant installation and establishment period).

Please distribute copies of this letter and wage determination to departments in your agency that may be involved in contracting out for landscape maintenance work.
